I expressly release Company from any and all claims arising out of the use as described above by Company of my name, likeness, image, photograph, voice, biography, interview, statements and/or performance, together with any materials I have submitted to Company, including but not limited to claims for blurring, distortion, or editing. I further expressly release and discharge Company of and from any and all claims arising from my participation, including, without limitation, any claims for defamation, false light, invasion of privacy, violation of the rights of publicity, breach of confidence, trademark infringement, unfair competition, and copyright infringement.

This agreement will in all respects be governed by and interpreted, construed and enforced in accordance with the laws of the State or Commonwealth in which the Station is located, without regard to conflict of law principles, and I submit to the jurisdiction of the courts within the same State or Commonwealth and waive all objections to the jurisdiction or venue of such courts. If any provision in this agreement is found to be invalid, unlawful or unenforceable to any extent, such provision shall be excluded from this agreement, which shall continue to be valid, lawful and enforceable in all other respects to the fullest extent permitted by law.

This agreement represents the entire understanding of the parties, and I am not relying on any other promises or statements made by anyone other than this agreement, which may not be amended unless mutually agreed to by both Company and myself in writing.
