Jurors' Choice Awards:

- Three Jurors' Choice Awards will be given to artworks selected by the jurors. The three Jurors' Choice Award winners will each receive \$200 in prize money.

II. EVENT INFORMATION:

- Artwork will be featured online for pre-bidding
- Artwork will be divided between the live and silent auctions at the discretion of the jurors and benefit auction consultant
- All artwork will be featured onstage at The Arts Night Experience and receive equal promotion through the catalog and social media
- Starting bid prices will be proposed by VAC staff and sent for confirmation before publication
- Artists will receive a free family membership to the Washington Pavilion and the option to choose one of the following perks: 25% of the auction sales price of your artwork, or one free ticket to the auction event (valued at \$125)
- A print catalog with an artist directory will be mailed to all Arts Night Experience attendees and artists
- Artists will be recognized at our Free First Friday reception on Feb. 2, 2018

V. SUBMISSION DIRECTIONS:

- Artists may submit up to two artworks for consideration
- Artwork(s) may be submitted for jurying in one of two ways:
 - Submit a digital image of your artwork in JPEG format to visualartscenter@washingtonpavilion.org. Images should be high quality and no smaller than 1000 pixels in any direction, and at least 72dpi.
 - Hand-deliver or ship the actual artwork to:

- The submission deadline for the Arts Night 2018 juried exhibition is **4 p.m. on Dec. 20, 2017**.
- We can only accept ready-to-hang, original artwork created by the artist submitting it.
- All submissions, electronic or actual artwork, **must** be accompanied by the submission form (see page 2)
- Hand-delivered or shipped entries that are **not** accepted must be retrieved by Jan. 5, 2018
